INSTRUCTIONS FOR PAYING OF FINES AND COSTS

If you wish to plead guilty to the offense(s) with which you have been charged, and have not been convicted of two or more driving offenses within the last 12 months, you **MUST SIGN** the yellow copy of the traffic citation which was issued to you and return the copy along with the correct amount of money for your citation. Your money must reach **this Office BEFORE YOUR COURT DATE**, and if it does not and you do not appear in court, a warrant may be issued for your arrest and your driver's license may be suspended.

If you are charged with an offense which is not listed below, or if you wish to plead not guilty to the charge, you **MUST** appear in court on the date and at the time listed on your citation.

NO PERSONAL CHECKS OR COMPANY CHECKS WILL BE ACCEPTED, YOU MUST SEND A MONEY ORDER OR CASHIER'S CHECK. Money orders or cashier's checks should be made payable and mailed to:
